CSA	Canadian Standards Association	Sets construction-related codes and standards.
ERP	Emergency Response Plan	Detailed plan outlining procedures during emergencies.
H2S	Hydrogen Sulfide	Toxic gas hazard — workers must be trained and equipped.
H&S	Health & Safety	Focuses on protecting workers and the public by preventing injuries, illnesses, and accidents on worksites.







HASP	Health and Safety Plan	Project-specific safety plan required on jobsites.
JSA	Job Safety Analysis	Helps integrate safety into job tasks by identifying hazards.
LEED	Leadership in Energy and Environmental Design	Green building rating system.
LOTO	Lockout/Tagout	Safety procedure ensuring machinery is properly shut off and not started up again until maintenance is complete.
MOL / OHS	Ministry of Labour, Immigration, Training and Skills Development / Occupational Health and Safety	Ontario provincial safety authority.
MSDS/SDS	Material Safety Data Sheet / Safety Data Sheet	Now called SDS — details hazardous material info.
OH&S / OHS	Occupational Health & Safety	General term for workplace safety laws/regulations.
PPE	Personal Protective Equipment	Equipment worn to minimize exposure to hazards. E.g. Hard hats, boots, gloves, eye protection, etc.
OHSA	Occupational Health and Safety Act	Governing legislation.
OHSNL	Occupational Health and Safety Division, Service NL	Newfoundland and Labrador Provincial Safety Authority.
PTW	Permit to Work	Formal authorization to perform hazardous work.
SCBA	Self-Contained Breathing Apparatus	Personal respiratory protective device.
SDS	Safety Data Sheet	Contains information about hazardous materials (new term replacing MSDS).
